2. Return the application with a non-refundable deposit of \$100 per contract court by May 7, 2010. All names listed must join the Bass River Tennis Club to participate in a contract time.
3. New contract times will be granted if space is available. Contract renewals have priority.
4. Once the contract season begins, the group representative must notify the club if there are any changes among players in their group. All billing of contracts is final on October 30, 2010. After this date, it is the responsibility of contract players to settle any unresolved billing issues amongst themselves.
